
committees as well as the Stewardship and Investment Suitability Committee. Prior to joining the team, Tristan worked within the Stonehage Fleming Equity Management team for three years.

### PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio B USD Class returned 2.6% in June vs 2.0% for the benchmark. Global equities continued their strong start to the year in June on the back of falling headline inflation and resilient economic data. US equities outperformed other regions, but there was generally much improved breadth at a regional, sector and company size level.

The equity book trailed global equity markets in aggregate. Whilst there was improved breadth, the lower allocation to the largest seven companies remaining a headwind as they continued to perform well e.g. Tesla +28% and NVIDIA +12%. Some of the strategies that fared less well included GLG Undervalued Assets having been impacted by some of the housebuilders falling on rising UK rates. Veritas Asia also had a weaker month given the higher allocation to healthcare companies. On the positive side, most of our smaller company strategies, such as Dimensional and Driehaus, had a stronger month.

Fixed income markets were mixed in the month with core governments bonds seeing negative returns from rising yields, but there was better performance within credit as spreads narrowed. In line with these moves, our better performing positions were those with credit exposure, with PIMCO Income the best performing position in the month.

The majority of the Alternatives book delivered positive absolute returns in the month with both long/short strategies rising and the best performer being our position in Catastrophe bonds. The only negative offset was our gold position which has continued to give back some of its gains for the year.
