PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio B USD Class returned 3.0% in October vs 1.9% for the benchmark. Most equity markets delivered positive returns in October. Businesses trading on lower valuation multiples, and smaller and more economically sensitive companies, outperformed during the month, with Energy reporting particularly strong earnings in the US. Regionally, the US outperformed, whilst China lagged significantly as investors reacted negatively to changes to the CPC Central Committee.

The equity book added value versus broader global equity markets when looking at the underlying stocks, but underlying Fund and ETF timing was a headwind. Of particular note was the good performance of those strategies with a bias to small and medium sized companies. These included our new global small cap value strategy, Dimensional, and our UK value strategy, GLG Undervalued Assets. It was also another good month for our thematic strategies in healthcare and insurance, which unusually protected capital well in September and also outperformed in the bounce in October.

Within Fixed Income, it was a mixed month as rates rose, leading to losses in longer duration positions. However, there was good performance from our TIPS position and PIMCO Income, with the latter benefitting from spreads narrowing. The Alternatives book also had a mixed month with gold and long/short manager, Sandler, delivering negative returns. There was positive performance though from long/short manager, MW ESG TOPS, and from our catastrophe bond Fund.

ACTIVE MANAGER IN FOCUS

Artisan US Focus Fund

The Artisan US Focus Fund is an equity fund investing predominantly in the US market. The team employ an investment philosophy which blends in-depth thematic idea generation with bottom-up fundamental stock selection. They start by seeking out inflections in multi-year trends, which are often misunderstood by the market, allowing them to take a differentiated view on industry fundamentals.

The team use their approach to construct a focused portfolio of 20-40 stocks, which is designed to maximise alpha whilst limiting downside risk. These stocks will typically sit across 5-8 themes, with each theme sized around 10%-30%.

The fund is managed by Chris Smith and is supported by a team of 7 investment professionals. The manager is not wedded to a philosophical style bias, and is very mindful of factor risks in the portfolio. Historically the fund has however demonstrated leanings towards some more growth thematics, though the manager has actively sought to balance this risk and introduce more value themes at various times.
