




Fleming Equity Management team for nearly four years where he was responsible for a variety of investment and operational functions, during a period of strong growth for the team.



#### PORTFOLIO COMMENTARY

The Global Multi Asset Portfolio Class B returned -2.1% in September versus -1.6% for the new Morningstar benchmark\*. After a strong recovery in risk assets since mid-March, equities and credit gave back some of their gains in September, as investors weighed up rising coronavirus cases and reimposed restrictions. As a result, more defensive assets fared better, including long duration government bonds, and within equity markets, sectors like Consumer Staples, Healthcare and Utilities held up relatively well.

Within the equity book, we saw better relative performances from our managers focusing on higher quality and growth businesses, including Findlay Park, Edgewood, Stonehage Fleming Global Best Ideas and Fidelity Emerging Markets; the majority of the allocation to active equity managers are to strategies that focus in these areas of the market. Strategies which faired less including our UK manager, GLG, and our non-life insurance strategy, Polar; the former impacted by rising cases in UK and negative Brexit sentiment and the latter over concerns around business interruption insurance claims. Both strategies have a lower weighting reflecting risks, but we see notable upside over the medium to long-term.

Outside of equities, our emerging market debt manager, BlackRock, had a more difficult month as risk appetite fell. However, our holdings in fixed income with longer duration, including our Global Aggregate Bond ETF and our USTIPS position, held up well.

\*In response to demand for a suitable peer group performance comparator, the directors decided it was appropriate for the benchmark to be changed to the Morningstar USD Moderate Allocation Category average - a category our fund has been assigned to by Morningstar based on fund composition (35-65% equities) and one which we believe is a more representative benchmark given our investment strategy.

### **ACTIVE MANAGER IN FOCUS**

### BlueBay Global Investment Grade Corporate Bond Fund

Bluebay Global IG represents an allocation to traditional, "pure-play", investment grade credit with a quality biased "stock-picker" fund manager. Exposures are predominantly long but the team can implement a negative view on credits or indices through credit default swaps (CDS). The main driver of performance and focus from the manager is bottom-up credit selection and thorough fundamental analysis, although the fund can also take advantage of opportunistic dislocations in credit markets. In a challenging year for risk, the fund has outperformed the broader investment grade space through credit selection, having positioned the portfolio well in both the sell-off and recovery.
