PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio B USD Class returned -5.5% in September vs -5.8% for the benchmark. Global equity markets saw steep falls in September as investors continued to price in further rate rises from central banks to control inflation and an increasing probability of a global recession.

Within the equity book, absolute returns were weak across the board, but there was relative value added. Our thematic strategies in insurance and healthcare both held up well and continued their good performance for the year. There was also some better relative performance from some of our growth strategies, such as Veritas and Driehaus, which both had a difficult first half of the year.

It was another difficult month within for the fixed income book with both duration and credit impacted by the pick-up in rates and risk-off sentiment. The Alternatives book had a mixed month with the long/short managers delivering positive absolute return, but there was weakness in the GAM Star Cat Bond Fund falling the damage caused by Hurricane Ian.

Activity during the month included selling Edgewood, our US Growth strategy. The position was sold following concerns on the resilience of the earnings on some of their underlying companies, many of whom were beneficiaries of the pandemic. Proceeds were reinvested in the S&P 500 ETF and Findlay Park.

ACTIVE MANAGER IN FOCUS

Artisan US Focus Fund

The Artisan US Focus Fund is an equity fund investing predominantly in the US market. The team employ an investment philosophy which blends in-depth thematic idea generation with bottom-up fundamental stock selection. They start by seeking out inflections in multi-year trends, which are often misunderstood by the market, allowing them to take a differentiated view on industry fundamentals.

The team use their approach to construct a focused portfolio of 20-40 stocks, which is designed to maximise alpha whilst limiting downside risk. These stocks will typically sit across 5-8 themes, with each theme sized around 10%-30%.

The fund is managed by Chris Smith and is supported by a team of 7 investment professionals. The manager is not wedded to a philosophical style bias, and is very mindful of factor risks in the portfolio. Historically the fund has however demonstrated leanings towards some more growth thematics, though the manager has actively sought to balance this risk and introduce more value themes at various times.
