PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio B USD Class returned 1.7% in September vs 1.7% for the benchmark.

The global economy continued to moderate following strong growth earlier in the year. Inflation and labour market data cooled, prompting the Fed to cut interest rates by half a percentage point. Global equities continued to climb, propelled by the start of the US easing cycle and China's latest monetary and fiscal stimulus package.

Equities produced good absolute returns but slightly underperformed the global equity market. Our global equity manager, Stonehage Fleming Global Best Ideas Equity, experienced some stock-specific issues, whilst Veritas Asian underperformed its region due to holding overweight exposure to South Korea. From an allocation perspective our underweight exposure to Emerging Markets and overweight exposure to the UK and health care detracted from relative performance, although our UK active manager Man GLG performed well in the market environment.

Yields moved lower during the month and the fixed income portfolio outperformed, driven by longer duration US Treasuries and exposure to investment grade corporate bonds.

Alternatives had another very strong month, with gold performing well in the market environment and all but one of our positions outperforming the broader hedge fund industry.
