

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio C GBP Class returned -2.0% in December vs -2.2% for the benchmark. There was notable variation in regional equity performances with US equities particularly weak whilst most other regions were close to flat in US dollar terms. Part of the explanation for the weaker US performance is the continuing slide in the US dollar and the weak performance of the Technology sector, which is well represented within the US.

Within the equity book, absolute returns were negative but the book fell less than global equity markets. Our thematic strategies in insurance and healthcare continued to protect capital well as they have done for most of the year. There was also some better performances from our more contrarian UK and European managers, with the latter particularly seeing a good bounce after struggling in the risk-off sentiment in Q3.

It was a similar story with the Fixed Income book with absolute returns negative as rates rose in the month, but value was added versus broader global fixed income markets. One of their better relative contributors was PIMCO Income, which was flat in US dollar terms for the month, and helped by its conservative duration positioning. Our Alternatives book had a good month with positive returns in US dollars across the board – gold and both our long/short managers had a particularly good month.

There was minimal activity within the strategy during the month.

ACTIVE MANAGER IN FOCUS

Artisan US Focus Fund

The Artisan US Focus Fund is an equity fund investing predominantly in the US market. The team employ an investment philosophy which blends in-depth thematic idea generation with bottom-up fundamental stock selection. They start by seeking out inflections in multi-year trends, which are often misunderstood by the market, allowing them to take a differentiated view on industry fundamentals.

The team use their approach to construct a focused portfolio of 20-40 stocks, which is designed to maximise alpha whilst limiting downside risk. These stocks will typically sit across 5-8 themes, with each theme sized around 10%-30%.

The fund is managed by Chris Smith and is supported by a team of 7 investment professionals. The manager is not wedded to a philosophical style bias, and is very mindful of factor risks in the portfolio. Historically the fund has however demonstrated leanings towards some more growth thematic, though the manager has actively sought to balance this risk and introduce more value themes at various times.
