PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio C GBP Class returned -1.9% in February versus -1.7% for the benchmark. Global equities returned -2.6% (USD) during the month whilst global fixed income assets also fell, returning -1.4% (USD). Holding more equity risk in the fund detracted from relative performance under these market conditions but the fund benefited from limiting its exposure to duration. We are also holding an increased cash position which contributed positively as markets sold off.

Some of our equity managers including Stonehage Fleming Global Best Ideas struggled in the market conditions as growth and quality continued to underperform despite the risk-off environment. Fidelity Emerging Markets was hit by holding a small overweight position in Russian securities.

Within fixed income, the iShares China CNY Bond ETF and TIPS position produced positive returns but our credit-focused positions in PIMCO Income and BlueBay Global Investment Grade Corporate Bond sold off.

Our gold position contributed very positively to returns as it rallied 6% (USD) amid concerns around inflation and geopolitical developments.

At the beginning of the month we sold our position in the BlackRock Emerging Markets Local Currency Bond fund, which was beneficial to performance as the asset class sold off following events in Ukraine.

ACTIVE MANAGER IN FOCUS

Artisan US Focus Fund

The Artisan US Focus Fund is an equity fund investing predominantly in the US market. The team employ an investment philosophy which blends in-depth thematic idea generation with bottom-up fundamental stock selection. They start by seeking out inflections in multi-year trends, which are often misunderstood by the market, allowing them to take a differentiated view on industry fundamentals.

The team use their approach to construct a focused portfolio of 20-40 stocks, which is designed to maximise alpha whilst limiting downside risk. These stocks will typically sit across 5-8 themes, with each theme sized around 10%-30%.

The fund is managed by Chris Smith and is supported by a team of 7 investment professionals. The manager is not wedded to a philosophical style bias, and is very mindful of factor risks in the portfolio. Historically the fund has however demonstrated leanings towards some more growth thematics, though the manager has actively sought to balance this risk and introduce more value themes at various times.
