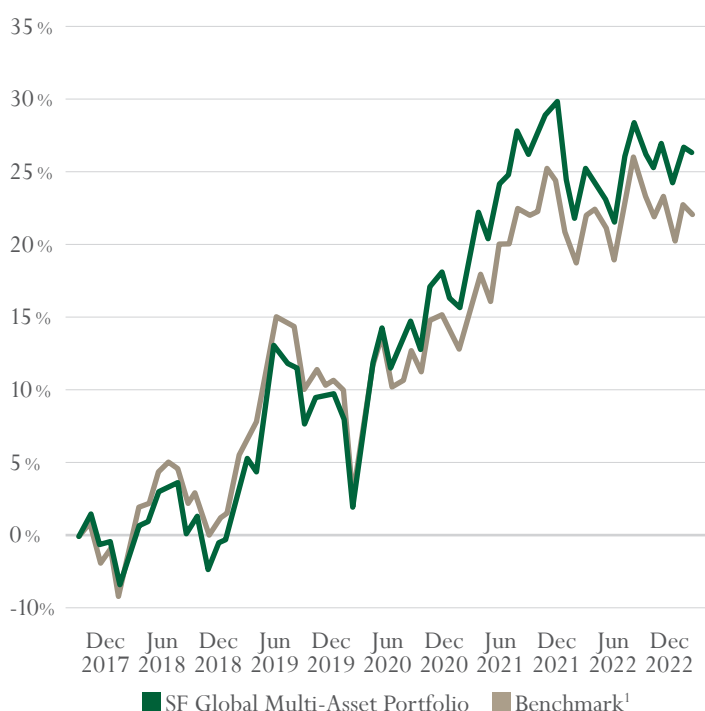

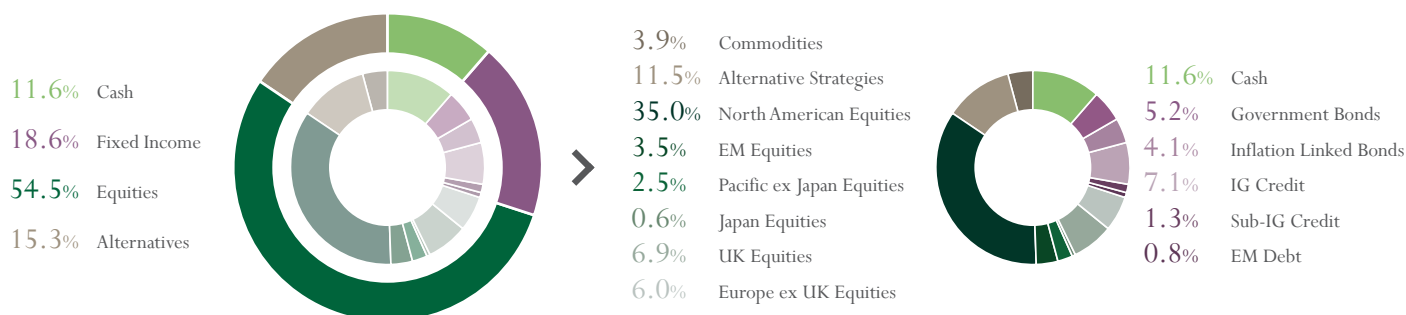
TRISTAN DOLPHIN, CFA

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio C GBP Class returned -0.2% in February vs -0.4% for the benchmark. After a strong start to the year, equity markets cooled in February as investors grappled with resilient economic data potentially lengthening the rate hike cycle. UK and Continental Europe performed better than other regions. Emerging markets had a weaker month, with China down amid profit taking and a resurgence in geopolitical tensions with the US. There was a notable divergence in style performance across regions. Higher growth companies outperformed lowly valued companies in the US; however, the opposite was true in other regions. More economically sensitive sectors outperformed, while rate sensitive areas lagged.

Within the equity book, absolute returns were negative but outperformed broader equity markets. One of the tailwinds was the regional allocation with more capital in the UK and less capital in Japan – the former performing well and the latter struggling. Both of our dedicated small cap strategies, Driehaus and Dimensional, outperformed with Driehaus delivering good stock selection and Dimensional benefitting from its more cyclical tilt. Also of note was the continued good start to the year on a relative basis from JO Hambro.

Our Fixed Income holdings fell in the month in US dollar terms as stronger than expected economic data pushed bond yields higher. Selection within the space was close to neutral and there was little variation across strategies. Most of the positions within the Alternatives book had a positive month with the exception of the gold position, which fell on rising yields. The cash position helped protect capital during a difficult month for most asset classes.
