
committees as well as the Stewardship and Investment Suitability Committee. Prior to joining the team, Tristan worked within the Stonehage Fleming Equity Management team for three years.

PORTFOLIO COMMENTARY

The Global Multi-Asset Portfolio C GBP Class returned 1.7% in January vs 1.9% for the benchmark. Equity markets started the year on a strong footing following further signs of moderating inflation, reducing the pressure on central banks to be determinedly hawkish. Defensive areas of the equity market, such as Healthcare and Consumer Staples, notably lagged other sectors as risk appetite picked up. It was the Consumer Discretionary, Communications and Technology sectors that performed particularly well, with many of the recent losers seeing a significant bounce in their shares e.g. Tesla and Amazon. Regionally, there was little variation, but emerging markets were slightly ahead of developed markets.

Within the equity book, absolute returns were positive but trailed broader equity markets. Our two non-sector global strategies, Stonehage Fleming Global Best Ideas (GBI) and Dimensional, both delivered good returns despite very different style exposures. GBI benefitted from a number of its luxury names performing well (LVMH, Estee Lauder) whilst Dimensional was helped by cyclical names doing better (United Rentals). There was also good performances from our more valuation oriented UK and European strategies, GLG and JO Hambro. It was the more defensive strategies which struggled during the month, with our insurance and healthcare strategies underperforming after a strong 2022.

Our Fixed Income book performed well during the month with holdings in PIMCO Income and Bluebay Global Investment grade delivering strong returns as bond yields fell and credit spreads tightened. Our Alternatives book had a positive month in USD terms in aggregate with gold rising notably and there was positive performance from our catastrophe bond position.

Activity during the month included selling our holding in Fidelity Emerging Markets and buying Prusik Asia Equity Income. This was done with a view to better balance the Asia exposure from a style perspective and taking advantage of low valuations within the Asia equity income universe.

ACTIVE MANAGER IN FOCUS

Artisan US Focus Fund

The Artisan US Focus Fund is an equity fund investing predominantly in the US market. The team employ an investment philosophy which blends in-depth thematic idea generation with bottom-up fundamental stock selection. They start by seeking out inflections in multi-year trends, which are often misunderstood by the market, allowing them to take a differentiated view on industry fundamentals.

The team use their approach to construct a focused portfolio of 20-40 stocks, which is designed to maximise alpha whilst limiting downside risk. These stocks will typically sit across 5-8 themes, with each theme sized around 10%-30%.

The fund is managed by Chris Smith and is supported by a team of 7 investment professionals. The manager is not wedded to a philosophical style bias, and is very mindful of factor risks in the portfolio. Historically the fund has however demonstrated leanings towards some more growth thematics, though the manager has actively sought to balance this risk and introduce more value themes at various times.
