

#### MANAGER PERFORMANCE HIGHLIGHTS

An overweight to SMID was a tailwind to relative performance as large caps declined more significantly. All managers outperformed their benchmarks with the exception of Comgest Japan , which was due to their growth bias. On sectors, an underweight to Technology Hardware & Equipment (predominantly Apple, which declined -6%) and Automobiles & Components (predominantly Tesla, which declined 54%) in the quarter contributed, as did an overweight to Industrials. However, stock selection within the sector detracted, in particular a lack of aerospace and defence names, which performed well, are absent from this portfolio.


