- We are conviction led investors with all investments carefully assessed for purpose and purity.

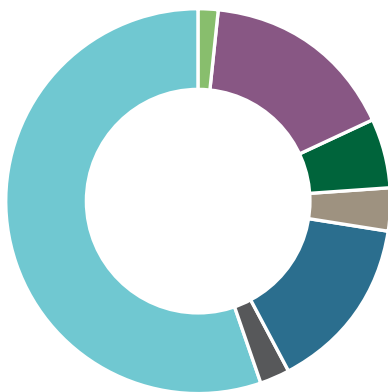
## MANAGER PERFORMANCE HIGHLIGHTS

GRIF outperformed global equities in Q4 2023 as the outperformance of Growth as well as small and mid-caps and the weak performance of the Energy sector were relative tailwinds for the strategy. The relative headwind of being underweight the “Magnificent 7”<sup>1</sup> was also less extreme. Most underlying managers outperformed broader global equities over the quarter, with Regnan Global Equity Impact Solutions particularly strong, helped by a number of investments into environmental names, which were helped in part by COP28’s missive to “transition away from fossil fuel”.
