

### MANAGER PERFORMANCE HIGHLIGHTS

MONA SHAH, CFA

GRIF was slightly behind global equities in Q1. An overweight to Europe and Japan were marginal tailwinds to relative performance and US growth manager Edgewood was the standout performer as investors favoured both Growth as a style and the IT sector (where Edgewood are meaningfully overweight), above more cyclical exposures and specifically Financials following the collapse of SVB and Signature Bank in the US; GRIF's underweight to Banks was a tailwind to relative performance. Regnan lagged, with names such as steel and aluminium recycling services company Befesa detracting after missing EBITDA guidance.


