## INVESTMENT STRATEGY

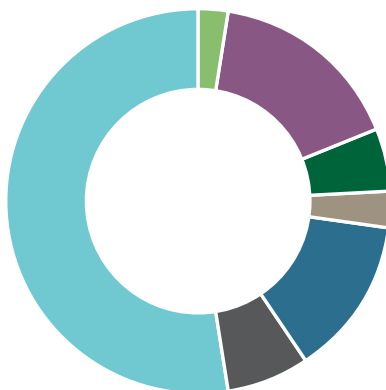
- We construct globally-orientated portfolios of long-term investment ideas.

## MANAGER PERFORMANCE HIGHLIGHTS

GRIF was disappointingly 3% behind global equities in Q3. Very few of our active exposures were rewarded by markets. Higher rates for longer weighed heavily on share prices for smaller companies and renewable stocks which are our key overweights. Conversely, the zero weight the portfolio has to energy hurt the most as it was the only sector that produced strong double digit returns. Finally, the underweight to the “Magnificent 7” and the US was a benign risk in the portfolio this quarter, it was the impact of rate rises that determined sector divergence.
