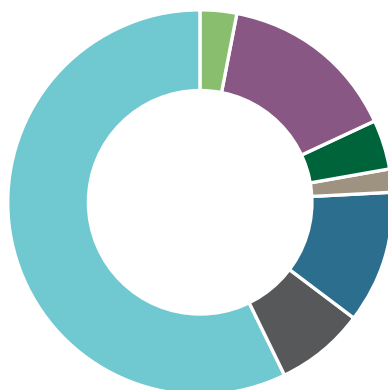

## FUND MANAGER

Mona is a Director of Stonehage Fleming Investment Management in London and is a member of the Investment Committee. Prior to joining the Group in 2018, Mona was Head of Collectives Research at Rathbone Investment Management and she now specialises in socially responsible investment and the application of impact measurement to publically listed equities.

## MANAGER PERFORMANCE HIGHLIGHTS

An overweight to SMID was a tailwind to relative performance as large caps declined more significantly. All managers outperformed their benchmarks with the exception of Comgest Japan, which was due to their growth bias. On sectors, an underweight to Technology Hardware & Equipment (predominantly Apple, which declined -6%) and Automobiles & Components (predominantly Tesla, which declined 54%) in the quarter contributed, as did an overweight to Industrials. However, stock selection within the sector detracted, in particular a lack of aerospace and defence names, which performed well, are absent from this portfolio.
