







INVESTMENT OBJECTIVE

RESPONSIBLE APPROACH

The Fund aims to achieve capital growth over the longer term by investing in companies that are progressively becoming more sustainable therefore creating a portfolio that is aligned to the UN Sustainable Development Goals¹.

MANAGER PERFORMANCE HIGHLIGHTS

The fund had a positive quarter in sterling terms for Q4, but fell in US dollar terms due to sterling weakening against the dollar over the quarter. Global equity performance was primarily driven by US stocks, which were bolstered by the outcome of the US presidential election. Considering this, our top performers for the quarter were the Amundi S&P 500 Climate Net Zero and the Findlay Park American Fund, both outperformed global markets due to their high allocation to US equities.

The impact-focused areas of the portfolio delivered returns behind our broader less thematically focused strategies. Despite this, several small-cap, impact-focused companies such as Joby Aviation (electric aircraft), and Rivian (electric vehicles) achieved impressive returns. At the beginning of the quarter, we divested from our global impact strategy, Regnan, which proved beneficial as the fund continued to decline. Proceeds were reallocated across the existing holdings.

Our investment philosophy for the strategy leads us to hold less in harmful areas. This was helpful in Q4 as oil and gas companies underperformed on subdued China demand and supply remaining resilient. We also believe the risks remain tilted to the downside in 2025 as the incoming US administration favours additional US supply and a prompt resolution to the Ukraine/Russia conflict. Both of which would likely put downward pressure on energy prices and lead to lower earnings for oil and gas companies.




