INVESTMENT OBJECTIVE

The Fund aims to achieve capital growth over the longer term by investing in companies that are progressively becoming more sustainable therefore creating a portfolio that is aligned to the UN Sustainable Development Goals**.

MANAGER PERFORMANCE HIGHLIGHTS

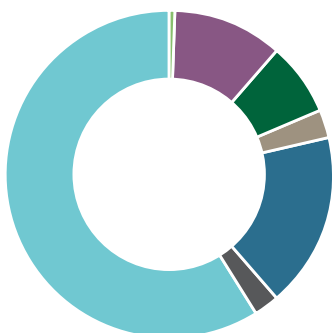
The Fund posting strong gains in US dollar terms in Q3, but was close to flat in sterling terms as sterling strengthened against the dollar. After two quarters of significant headwinds for sustainable equity investors, including a dominant technology sector and central bank rate cuts being pushed out, Q3 was a more favourable backdrop. Despite resilient tech earnings, market weariness of the strong gains and valuation levels led to notable volatility – NVIDIA fell over 25% between July and August at one stage. While portfolios have some exposure to the largest technology companies that exposure is more selective and lower in quantum. As a result, less of this volatility was experienced.

In the US, the Federal Reserve cut interest rates for the first time since 2020, lowering the Federal Funds Rate by half a percentage point to 4.75%-5%. This monetary policy shift boosted rate-sensitive market segments, particularly benefiting smaller companies. Earlier this year, we noted that the market's preference for larger companies over smaller ones had been a headwind for our portfolios. Many companies providing solutions to the climate transition, health issues and other global challenges are less mature businesses, often falling into the smaller and medium sized company category.

We're now seeing this headwind gradually dissipate. Notably, two of the strongest performing funds over the quarter were Impax Environmental Markets and Rockefeller Climate Solutions, both of which focus on small and medium sized companies addressing environmental challenges.
