Product

The Central Bank of Ireland is responsible for supervising Carne Global Fund Managers (Ireland) Limited in relation to this Key Information Document.

The Fund is authorised in Ireland and regulated by the Central Bank of Ireland.

The Fund is managed by Carne Global Fund Managers (Ireland) Limited (the "Manager") which is authorised in Ireland and regulated by the Central Bank of Ireland. Stonehage Fleming Investment Management Limited (the "Investment Manager") has been appointed as investment manager to the Fund.

What is this product?

Type: The Fund is domiciled in Ireland and is an open-ended investment company ("OEIC") and qualifies as an undertaking for collective investment in transferable securities ("UCITS").

Intended retail investor: The Fund is suitable for investors seeking long-term capital appreciation with an initial subscription of USD 1,000,000. In addition Share Classes may be offered to investors who are (i) clients of the Investment Manager or its associates and may be subject to minimum account maintenance or other qualifications established from time to time by the Investment Manager or its associates, (ii) any institutional investor or distributor, paying agent, broker or other financial intermediary or (iii) any employee of the Investment Manager.

Term: This Fund has no maturity date.

Objectives:

The investment objective of the Fund is to achieve capital growth over the longer term by investing in a blend of collective investment schemes which either have a sustainable investment objective or promote environmental and/or social characteristics.

The Fund performance will be measured against the MSCI All Countries World (ACWI) Net Total Return Index (the "Benchmark") and the MSCI ACWI Sustainable Development Index USD Net Total Return (the "Secondary Benchmark") together referred to as the "Benchmarks".

The Fund is considered to be actively managed in reference to the Benchmarks by virtue of the fact that it uses the Benchmarks for performance comparison purposes. Certain elements of the Fund's securities may be components of and may have similar weightings to the Benchmarks. However the Benchmarks are not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmarks.

In seeking to achieve its investment objective, the Fund will invest predominantly in a range of underlying collective investment schemes (the "Underlying Funds") which comply with the Central Bank's requirements as regards investment by a UCITS in other collective investment schemes and where such Underlying Funds provide exposure to a portfolio of assets comprising mostly global equities and equity related securities (which may be listed or traded on Recognised Exchanges or unlisted) and cash.

Such Underlying Funds may also provide exposure to other elements, being bonds (including corporate debt securities and bonds issued by sovereign, supranational entities and/or corporate issuers rated investment grade at time of purchase from either Moody's or another generally recognised international rating agency), non-investment grade debt, emerging markets, and infrastructure exposure (e.g. solar and wind power generation), subject to and in accordance with the investment restrictions set out in the Prospectus.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less than your original investment. In addition to the market price risk, please refer to the Fund's Prospectus for further information.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The value of your investment may fall and you may not get back the amount you invested.

Sustainability Risk - The fund may be subject to sustainability risk, meaning an environmental, social or governance ("ESG") event or condition that, if it occurs, could cause an actual or a potential material negative impact on the value of an investment.

What happens if Carne Global Fund Managers (Ireland) Limited is unable to pay out?
