Objectives and Investment Policy

The investment objective of the Fund is to achieve capital growth over the longer term by investing in a blend of collective investment schemes which either have a sustainable investment objective or promote environmental and/or social characteristics.

In seeking to achieve its investment objective, the Fund will invest predominantly in a range of underlying collective investment schemes (the "Underlying Funds" which comply with the Central Bank's requirements as regards investment by a UCITS in other collective investment schemes and where such Underlying Funds provide exposure to a portfolio of assets comprising mostly global equities and equity related securities (which may be listed or traded on Recognised Exchanges or unlisted) and cash.

Such Underlying Funds may also provide exposure to other elements, being bonds (including corporate debt securities and bonds issued by sovereign, supranational entities and/or corporate issuers rated investment grade at time of purchase from either Moody's or another generally recognised international rating agency), non-investment grade debt, emerging markets, and infrastructure exposure (e.g. solar and wind power generation), subject to and in accordance with the investment restrictions set out in the Prospectus.

Essential features of the Fund:

The Fund has the discretion to invest in a range of investments as described above.

The Fund performance will be measured against MSCI All Countries World (ACWI) Net Total Return Index (the "Benchmark") and the MSCI ACWI Sustainable Development Index USD Net Total Return (the "Secondary Benchmark") together referred to as the "Benchmarks". The Fund is considered to be actively managed in reference to the Benchmarks by virtue of the fact that it uses the Benchmarks for performance comparison purposes. Certain elements of the Fund's securities may be components of and may have similar weightings to the Benchmarks. However, the Benchmarks are not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmarks.

The Fund is considered to be actively managed in reference to the Benchmarks by virtue of the fact that it uses the Benchmarks for performance comparison purposes. Certain elements of the Fund's securities may be components of and may have similar weightings to the Benchmarks. The Fund has no specific industry, sector, or geographic focus.

The Fund may be invested up to 100% in other collective investment schemes.

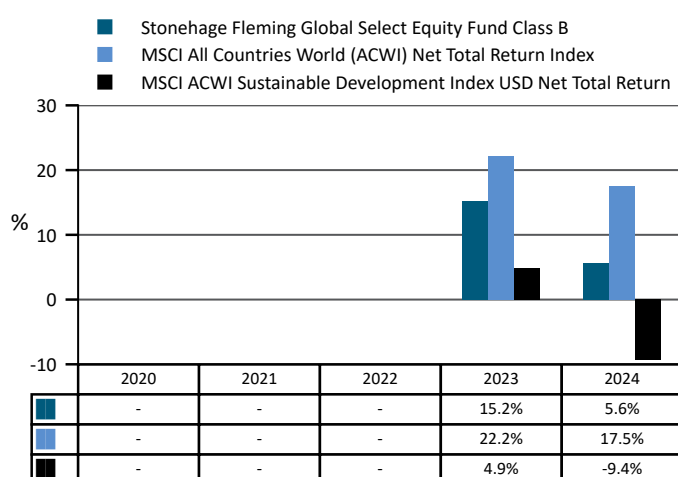
The ongoing charges figure may vary from year to year.
