MANAGER PERFORMANCE HIGHLIGHTS

Performance was very disappointing as inflation concerns, rising rates and oil dependency came to the fore. There seemed to be a change of sentiment in March and it was the clean energy parts of the portfolio that drove the rebound. Many areas of the portfolio still look oversold, and this is corroborated by managers in our mainstream portfolios too. For example, biotechnology and semiconductors which are today fundamental for any digital infrastructure. The overall portfolio has de-rated from 28x median P/E at its peak which was early last year to 21x which is akin to December 2019.


