COMMENTARY

Global equity and credit markets had their worst quarter in three years as concerns about weakening Chinese growth spilled over into concerns about global growth. Even the US Federal Reserve's decision not to raise interest rates in September failed to provide relief to markets and instead seemed to confirm these same concerns, leading to further capital losses.


US and European equity returns, helped by the weakeness in sterling, were the best relative performers whilst Emerging markets were the worst at almost 15% down in aggregate. Defensive sectors outperformed in aggregate, with consumer staples and utilities the best performers over the period, whilst commodity linked sectors such as energy and materials were the worst performers.

The Fund outperformed against this backdrop over the quarter, returning -3.4% against the benchmark return of -6.1%.

The roster of managers provided relative defensive performance in aggregate, helping to preserve the fund's capital. Notable performers were the Stonehage Fleming UK Equity Income and Polar Capital Global Insurance funds, whilst the FF&P US All Cap Value and GLG Japan CoreAlpha funds lagged as value investing remained out of favour. The Fund's regional exposure to US and European equities and away from Emerging markets were positive tactical tilts, especially given a weaker sterling over the period.

There was one change to the underlying holdings over the period, with the sale of the Coupland Cardiff Asian Evolution fund which had struggled with the difficult environment for their emerging market holdings.


