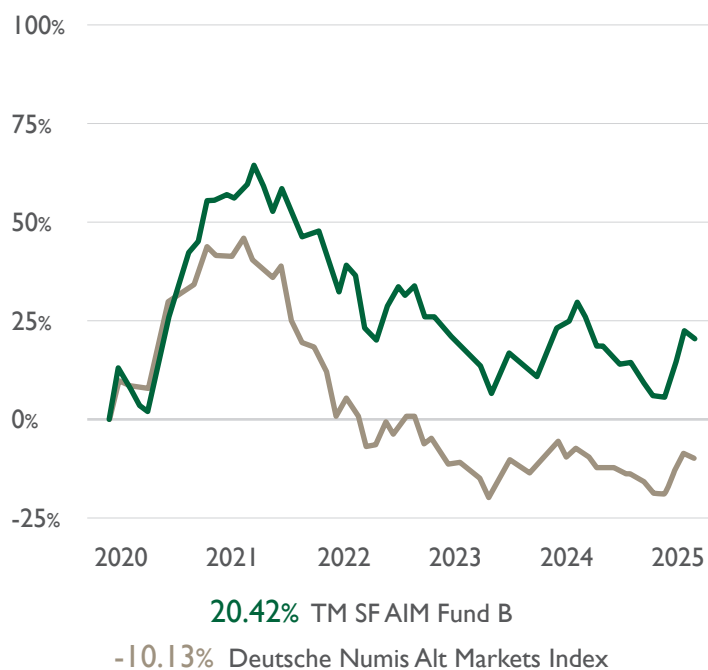
## INVESTMENT OBJECTIVE

## INVESTMENT POLICY

The Fund aims to invest mainly in equities on the UK Alternative Investment Market ('AIM'). This will be achieved by an actively managed diversified portfolio of shares spread across any sector of AIM. In addition, the Fund may on occasion invest in fully listed shares of companies with smaller market capitalisations.

## PORTFOLIO COMMENTARY

The major uncertainty in the month was the 1st August deadline set by the US President Donald Trump for countries to agree to US trade tariffs. It now has trade deals in place with twenty individual countries and reached an early agreement with the UK. At the end of the month it agreed a 15% tariff for European exports to the US. There was no resolution to the Russia/Ukraine war and President Trump has threatened to increase sanctions against Russia. Equally, the situation in Gaza shows little change. The month had mixed messages from the UK economy. GDP growth of around 1.0% to 1.2% is forecast for 2025, inflation for June was 3.6% against 3.4% in May and the Budget deficit was 4% higher than expected at £21bn. There is therefore the prospect of higher taxes which could stifle economic growth but to counteract this the Bank of England might be tempted to cut interest rates even though inflation remains above the 2% target. The Stock Market had a mixed month with investors' interest featuring more on larger companies with the FTSE 100 index moving into a new all-time high. Against this smaller companies and AIM shares entered after their recent outperformance and to reflect on the outcomes of the uncertain economic background.

On the basis that the government wishes to stimulate the housing market with ambitious new build targets coupled with at some stage interest rates will fall we have started a new holding in Brickability. The company is a leading distributor for the brick manufacturers and provider of specialist products for the construction industry and will benefit from an upturn in the building sector. We have also added to Ashted Tech (oil services) after the share price declined on the back of a disappointing trading update citing some geo-political disruption. To raise funds, we sold our holding in Gamma Communications (mobile software) which recently moved from AIM to the main market and also disposed of our interest in IDOX (software) where we see better potential elsewhere. Several AIM listed companies are looking to move to a full listing and specialist IHT funds are forced to reinvest when this occurs. This has created a technical situation where many of our holdings will attract additional investor demand. We are not obliged to sell immediately and the fund can sometimes benefit when one of our companies moves its listing from AIM to the main market and attracts a new investor base. The portfolio remains in good shape to take advantage of opportunities in the AIM sector.
