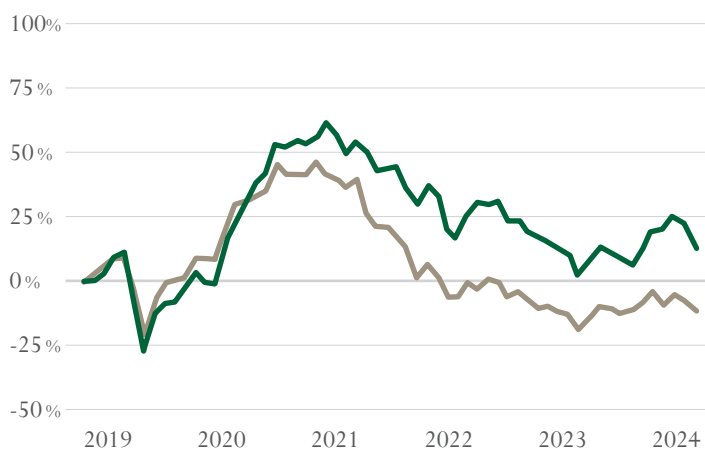
INVESTMENT OBJECTIVE

The fund aims to achieve long-term capital growth.

INVESTMENT POLICY

The Fund aims to invest mainly in equities on the UK Alternative Investment Market ('AIM'). This will be achieved by an actively managed diversified portfolio of shares spread across any sector of AIM. In addition, the Fund may on occasion invest in fully listed shares of companies with smaller market capitalisations.

PORTFOLIO COMMENTARY

One of the main points of interest in the month was the Labour Party Conference 2024 and whether Rachael Reeve, the new incoming Chancellor of the Exchequer, would leave any hints as to how the apparent £21.9 billion overspend by the previous Conservative Government would be clawed back in taxation. In the event she confirmed that there would be no change in income tax, corporation tax, national insurance and VAT but there was little else new to report. The reduction in the winter fuel allowance, new charge of VAT on public school fees and changes in "non-dom" tax status are measures that have already been disclosed. Rumours and thoughts on changes to pensions, capital gains and inheritance tax have circulated in news journals and it remains to be seen what the outcome will be when disclosed at the Autumn Budget on 30 October. Up until then investors remain cautious or perhaps nervous about the outcome and subsequently the Stock Market has drifted lower in the month. Worst affected have been smaller companies and particularly those listed on AIM as this approach is taken.

However, the Prime Minister stated that "the priority was to grow the economy with wealth creation the aim" and it is hoped that the Labour Government is more business friendly than many feared. The economic background is favourable with Sterling strong and inflation pegged at 2.0%. This leaves room for the Monetary Policy Committee (MPC) to follow the American lead to cut interest rates. We were able to take advantage of market changes by reducing several holdings which had outperformed. One of these was Synectics (surveillance systems) where the shares had a good outperformance on the back of upgraded results. Small additions were made to Next 15 (advertising) and IQE (semi-conductors) where prices are depressed and offer good recovery potential. The Stock Market can manage good news and bad news but not uncertainty and we would not expect to see a significant uptick until after the Autumn Budget measures are known. In the mean time we will continue to seek investment opportunities in order to position the portfolio to offer investors above average returns. Removal of political uncertainties and falling interest rates are likely to be positive factors.
