Objectives and Investment Policy

The objective of the Fund is to achieve capital growth and an element of income.

The Fund will generally only invest in Units in other regulated collective investment schemes. The Fund's assets will be invested predominantly in UK and international regulated equity funds. There may be some use of derivatives for Efficient Portfolio Management ("EPM"). It is likely that a significant proportion of the Fund's property will be invested in sub funds of another regulated collective investment scheme operated by the Investment Manager and called "Stonehage Fleming Global Equities Umbrella Fund" which is an authorised unit trust.

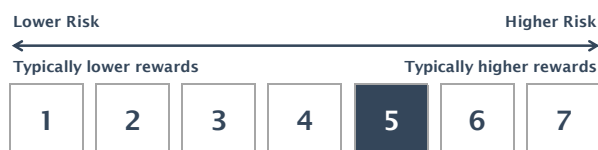
The Fund uses a composite benchmark of MSCI gross dividend indices - UK 45%, US 22%, Europe Ex UK 16%, Far East 10% Emerging markets 7%, for performance comparison purposes only and the benchmark is not a target benchmark and the fund is not constrained by it.

The indices have been selected as a benchmark for performance as a reflection of global equity markets and offer a clear comparator.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 10.30 pm.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

- The Fund has a concentrated portfolio (holds a limited number of investments) and if one or more of these investments declines or is otherwise affected, it may have a pronounced effect on the Fund's value.
- Significant exposure to a particular industrial sector or geographical region puts the fund at risk of a localised event making a significant impact on the value of the Fund.
- Where derivative or structured product investments in the Fund may include a counterparty, there is a risk that the counterparty will not fulfil their obligation.
- This Fund is allowed to use derivatives to achieve its objective. Derivatives can cause a Fund to become leveraged. Leverage occurs when exposure to an area invested in is greater than its amount invested, resulting in the Fund being exposed to a potentially greater loss than the initial investment.
- The Fund may use derivatives to reduce costs, overall risk and/or generate additional capital or income. This is known as Efficient Portfolio Management (EPM). When used for EPM purposes, there should not be an increase in the overall risk level of the Fund.

Charges for this Fund

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

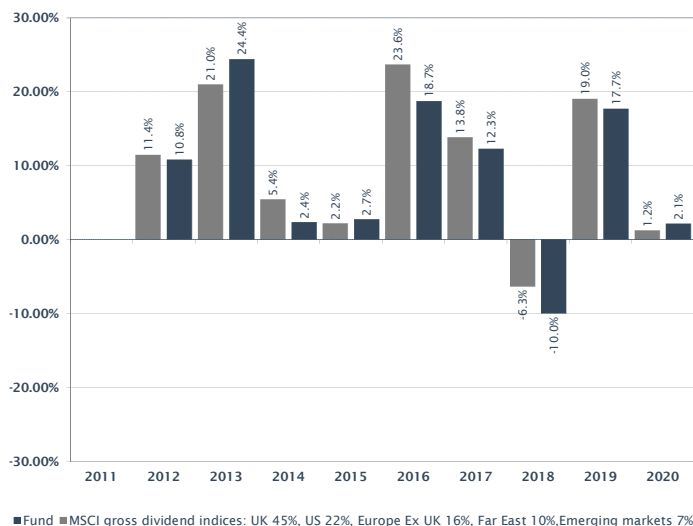
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
