FUND COMMENTARY

2024 will be remembered as one of the most difficult years for active investors, irrespective of their investment style. Whilst the market delivered fair positive absolute returns for many, most found it difficult to compete with popular indices. This can be ascribed to the popularity of a few large capitalization technology driven stocks that dominated index performance. The AI theme played a major role in the strong performance of the majority of these stocks.

In addition to this, the market was largely supported by the US economy and corporate earnings continuing to deliver above expectations, perceptions that US inflation is under control and the US election outcome. Against this, potential US trade tariff implications have raised new fears for inflation, interest rates and global trade war risks later on. Jerome Powell's caution around further cuts reinforced this dynamic. December saw some profit taking following the strong November performance, with an uncommon weak overall market for the month.

The best contributors to fund performance over December were Alphabet, Amazon and LVMH. Amazon continues to benefit from margin expansion, while positive perceptions around Alphabet's AI, their quantum computing chip and driverless car capabilities are growing strongly. LVMH, along with other luxury stocks, bounced from a weak November and constructive US holiday period sales. The largest detractors to performance were UnitedHealth, Eaton, and Adobe. UnitedHealth suffered from the assassination of their health care divisional CEO and regulatory fears. Eaton sacrificed its November gains, while Adobe shareholders were disappointed with management providing a lower than expected outlook.

The best contributors to performance over the full year were Amazon, Netflix and Alphabet. The Fund's strong positioning on the Fourth Industrial Revolution keeps delivering (Amazon and Alphabet). Despite Netflix being a relatively new addition to the fund, its strong advertising income outlook was well received by the market. Amongst the holdings, L'Oréal, Adobe and LVMH were the largest detractors from performance over the year. L'Oréal and LVMH continue to suffer from the weak Chinese consumer market, while Adobe's uncertain outlook was penalised.



OUTCOME OF FAIR VALUE ASSESSMENTS (2023)

- The fund meets the needs of the target market.
- The intended distribution strategy remains appropriate. Historically, the fund did not deliver value for money. In response, as of the 2nd August 2023, Stonehage Fleming Investment Management Limited changed the personnel managing the fund and the approach to investment selection. The fund will follow the strategy pursued by the Stonehage Fleming Global best ideas fund (GBI), and own the same quality growth business as this fund. INVESTOR PROFILE

The fund is appropriate for all investor types, including those with only a basic knowledge of funds.
