INVESTMENT OBJECTIVE

To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

The new year started on a positive note for equity markets. Capital markets continue to benefit from a resilient American economy with fourth quarter 2024 US GDP coming in at 2.3%. This brought growth for the calendar year to 2.5%, slightly above this century's average of 2.3%. The trusted Conference Board Leading Economic Index has turned decisively constructive, while the new US administration's policies are generally perceived to be pro-business, despite the risks around its proposed trade tariffs.

In the current earnings season, over a third of S&P 500 constituents have reported. So far, both the revenue and earnings results (+5% and +7% respectively), have beaten consensus expectations of +1% and +5% gains respectively. The 12-month forward consensus earnings growth expectation of +12% reflects confidence in the US economy continuing to deliver. On this basis, the forward earnings yield is equal to the 10-year Treasury yield, again reflecting high confidence in future operational delivery, but also leaving little margin for error on the inflation or interest-rate fronts.

The largest contributors to performance over the month were Amazon, EssilorLuxottica and Alphabet. Amazon is benefitting from the huge investments it made during the pandemic, with positive margin effects now coming through. EssilorLuxottica has evolved into the world's only vertically integrated eyewear business, while its partnership with Meta, to produce Ray-Ban smart frames, is starting to take form. Overall, the group enjoys solid long-term growth potential. Alphabet benefits from the strong US advertising market.

The largest detractors to performance were Edwards, Colgate and Amphenol, although their losses were marginal. There were no particular fundamental reasons over the month for softness in these shares.

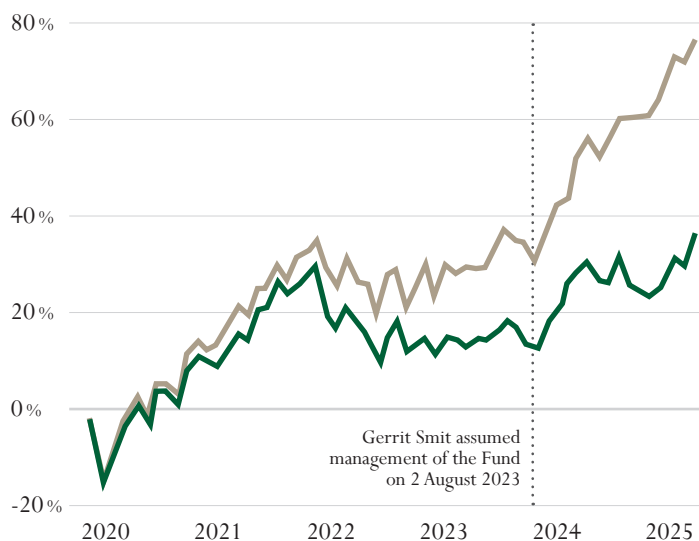

OUTCOME OF FAIR VALUE ASSESSMENTS (2024)

- The fund meets the needs of the target market.
- The intended distribution strategy remains appropriate.
- Historically, the fund did not deliver value for money. In response, as of the 2nd August 2023, Stonehage Fleming Investment Management Limited changed the personnel managing the fund and the approach to investment selection. The fund will follow the strategy pursued by the Stonehage Fleming Global best ideas fund (GBI), and own the same quality growth business as this fund. INVESTOR PROFILE

The fund is appropriate for all investor types, including those with only a basic knowledge of funds. It is compatible with investors who do not need a capital guarantee (investors must be prepared to accept fluctuations in the value of capital, including the ability to bear 100% capital loss) and are seeking capital growth.
