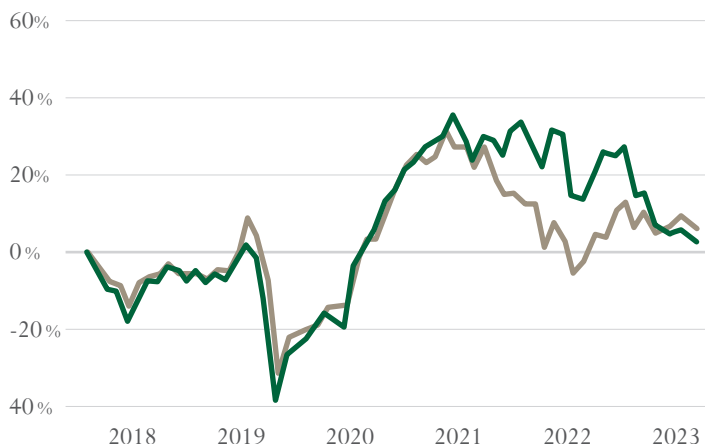
INVESTMENT OBJECTIVE

The fund aims to achieve long-term capital growth.

INVESTMENT POLICY

The Fund aims to invest in equities falling mainly under the following categories: smaller companies which offer long-term growth; companies which offer recovery prospects; and companies in sectors which are perceived to be unduly depressed. There is no geographical restriction but in practice the fund will be mainly invested in the UK.

PORTFOLIO COMMENTARY

August was a quiet month for company news and stock markets drifted lower. In the US, the rate of inflation for July increased from 3.2% to 3.7% but the UK inflation rate dipped from 7.9% to 6.8%.

The recent rise in energy prices might put additional pressure on inflation and interest rates. In the UK, the Bank of England increased interest rates by 0.25% to 5.25% and it is thought that there might be a further quarter point rise in September before they reach a peak. Oil prices have moved higher following the extension of production cuts by OPEC and Russia and moving forward much will depend on seasonal winter demand. Most companies that we see have taken action by hedging some energy costs and, where possible, passing on price inflation to consumers. We feel that even without a further increase in energy cost, companies in the oil and gas sector carry attractive valuations and would expect to benefit from our portfolio weighting. Our interests are mainly confined to companies, which have good production and operate in the North Sea. Elsewhere, we would look for favourable results from the companies held in the portfolio. Smaller companies and particularly those listed on AIM have underperformed in the last year with investors becoming risk averse. Many shares are substantially undervalued and we would look for a strong recovery once investor confidence has been restored. As such, we are bullish about the long-term outlook. Moreover, we have reduced a number of holdings and added to STV on the back of encouraging results.
