INVESTMENT POLICY

The Fund aims to invest in equities falling mainly under the following categories: smaller companies which offer long-term growth; companies which offer recovery prospects; and companies in sectors which are perceived to be unduly depressed. There is no geographical restriction but in practice the fund will be mainly invested in the UK.

PORTFOLIO COMMENTARY

The surprise US aerial attack on Iran nuclear facilities following renewed and heightened hostilities between Israel and Iran were the events which might have caused the most uncertainty in the month. Oil prices spiked but fell back to more normal levels when it was announced this was a 'one- off' event designed to encourage peace talks to commence. Elsewhere, conflicts continue in Ukraine and Gaza with the result that following a NATO summit in the Hague the member countries have committed to increased defence spending budgets. On the economic front, UK inflation in May was 3.4% against 3.5% in the previous month to reflect the higher cost of the UK Budget and uncertainty of Trump Tariffs. GDP in the first quarter of 2025 showed positive growth of 0.7% which was slightly better than forecast. Interest rates both in the UK and US remained unchanged and Sterling strengthened which was more to do with a weakness in the US Dollar. Positive news was the proposed trade deal between the United Kingdom and the United States of America and subsequently the UK stock market was very resilient in the month. More importantly, sentiment improved for UK smaller companies and the fund saw a substantial out-performance which was helped by positive company results from a number of our holdings.

June was an active month where we reduced three of our larger holdings which had outperformed in order to add to underweight holdings which had lagged and were considered to have considerable long-term upside potential. Also due to its size, for technical reasons we continued to reduce our holding in MS International. Additions to holdings included Ashtead Tech (energy services), Eagle Eye (promotional software), Harbour Energy (oil and gas production), Lion Trust (fund management) and Spirax (specialist engineering). We have seen a return of confidence from investors and a decent rise in share prices in many of our holdings. Smaller companies, including those with AIM listings, which are held by the Fund, have generally performed well as have the larger fully listed shares held for recovery. Assuming no change in investor sentiment, the fund is well placed to achieve out-performance over the short, medium and longer term.
