FUND OBJECTIVE

The objective of this portfolio is to provide above average growth in capital over the medium to long term. Income will be of secondary importance. The risk associated with this portfolio shall be the same as the risk associated with SA equities as an asset class. Volatility of capital can occur over the short-term.

FUND STRATEGY

The portfolio shall invest in assets in liquid form and in securities across all sectors of the JSE Securities Exchange of South Africa as well as international exchanges and other permissible assets allowed by the Act. The portfolio shall be allowed to invest in listed and unlisted financial instruments (derivatives) as allowed by the Act from time to time in order to achieve its investment objective, and shall be permitted to invest in offshore investments as legislation permits. This portfolio will invest predominantly in equities. Apart from the above, the portfolio may also invest in participatory interests of portfolios of collective investment schemes registered in the Republic of South Africa or of participatory interests in collective investment schemes.

The fund will be managed with a high conviction approach, typically holding no more than 20 positions at any time. In line with the investment manager's investment philosophy and process, the holdings will be concentrated in selected JSE Top 50 companies with the buy-to-hold management approach encouraging minimal portfolio turnover.

PORTFOLIO MANAGER QUARTERLY COMMENT

The Stonehage Fleming SCI Equity fund's 1st month of trading proved to be an extremely eventful one when, on the 23rd of June, the UK surprised markets by voting to leave the EU (termed "Brexit" in the media). The result of the vote will have wide-spread implications for the UK and EU, as well as global markets in the coming years. Global equity markets sold off sharply when the news broke, but recovered the majority of the losses towards the end of the month. The Sterling, UK Property and UK linked Financials all came under significant selling pressure immediately after the vote whilst more defensive sectors such as Healthcare, Tobacco and other staples were more resilient. One of the key consequences of the leave vote is that global interest rates (in key geographies) are likely to remain lower for longer. In a low interest rate environment, the attractiveness of companies with dependable and predictable distributions only becomes stronger.

Aspen had a strong month after announcing an agreement with AstraZeneca whereby Aspen acquires the rights to AstraZeneca's global (excl. the USA) anaesthetics portfolio. An additional supply agreement for 10 years was also signed with AstraZeneca. The deal gives Aspen an additional growth driver. Aspen's ability to distribute the anaesthetics through their existing global network and the later possibility of own production are notable synergies of the deal.




