1 PRIVACY POLICY

Stonehage Fleming Law Limited (“SFL”) is committed to protecting and respecting your privacy. SFL’s firm details can be found on the Legal Statements section on this site.

This policy (together with our terms of use-contained on the Legal Statements section of this site) sets out the basis on which any personal data SFL collects from you, or that you provide to us, will be processed and used by SFL. Please read the following carefully to ensure you understand our views and practises regarding your personal data and how we will treat it. By visiting www.stonehagefleminglaw.com (“our site”) you are accepting and consenting to the practice described in this policy.

This policy covers without limitation, the home page, splash page and all other pages under the domain name of our site and all content contained on those pages.

For the purposes of the Data Protection Act 1998 (the “Law”) the data controller is Stonehage Fleming Law Limited.

1.1 Information we may collect from you:

1.1.1 [Information you may give us.](#) You may give us information about you by filling in forms on our site or by corresponding with us via phone, email, facsimile or otherwise. This includes information you provide when you report an issue with our site. The information you give us may include your name, email address and phone number;

1.1.2 [Information we collect about you.](#) Each time you visit our site we may automatically collect the following:

1.1.2.1 technical information including the internet protocol (IP) address used to connect your computer to the internet, your log-in information, browser type and version, browser plug-in types and versions, time-zone setting, operating system and platform; and

1.1.2.2 information about your visit, including the Uniform Resource Locators (URL) clickstream to, through and from our site (including date and time); items you searched for; page response times; download errors, length of time spent on pages, page interaction information (such as scrolling, clicks and mouse-overs) and methods used to browse away from the page and any phone number used to call us.

1.1.3 [Information we receive from other sources.](#) We may receive information about you from third parties we work with (including for example analytic providers, search information providers, sub-contractors in technical services).

1.2 Uses made of information collected

SFL uses information held about you in the following ways:



1.2.1 Information you give to us. We will use this information:

1.2.1.1 to carry out our obligations arising from any contracts entered into between you and SFL and to provide you with the information, products and services that you request from us;

1.2.1.2 to provide you with information about other products and services that we offer that are similar to those that you have already purchase or enquired about;

1.2.1.3 to provide you with information about products or services we fell may interest you. If you are an existing customer, we will only contact you by electronic means with information about products and services similar to those which were the subject of prior dealings between us. If you are a new client, and where we permit selected third parties to use your data, we (or they) will contact you by electronic means only if you have consented to do this. If you do not want us to use your data in this way, or to pass your details on to third parties for marketing purposes, please tick the relevant 'opt out' box on the form on which we collect your data;

1.2.1.4 to notify you about changes to our service; and

1.2.1.5 to ensure that content from our site is presented in the most effective manner for you and for your computer.

1.2.2 Information we collect about you. We will use this information:

1.2.2.1 to administer our site and for internal operations including troubleshooting, data analysis, testing, research, statistical and survey purposes;

1.2.2.2 to improve our site and to ensure that content is presented in the most effective manner for you and your computer;

1.2.2.3 to allow you to participate in interactive features of our service, when you choose to do so; and

1.2.2.4 as part of our efforts to keep our site safe and secure.

1.2.3 Information we receive from other sources. SFL may combine this information with information you give to us and information we collect about you. SFL may use this information and combined information for the purposes set out above (depending on the types of information we receive).

1.3 Disclosure of your information

SFL may share your information with selected third-parties including:

1.3.1 suppliers and sub-contractors for the performance of any contract SFL enters into with them or you; and



- 1.3.2 analytics and search engine providers that assist us in the improvement and optimisation of our site.

SFL may disclose your personal information to third parties:

- 1.3.3 in the event that we buy or sell any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets; and
- 1.3.4 if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, where requested by regulatory agencies, or in order to enforce or apply our terms of use and other agreements or to protect rights, property or safety of SFL. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

1.4 Where we store your personal data

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area (EEA). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff may be engaged in, amongst other things, the provision of support services. By submitting your personal data you agree to this transfer, storage or processing. SFL will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this policy.

All information you provide to us is stored on secure servers.

We must advise you that the transmission of information via the internet is not completely secure. While we will do our utmost to protect your personal data we cannot guarantee the security of data transmitted to our site, any transmission is made at your own risk. Once SFL has received your information it will use strict procedures and security features to try and prevent unauthorised access.

1.5 Consent to processing

By providing any personal information to our site you fully understand and unambiguously consent to the transfer of such personal information to, and the collection and processing of such personal information in the United Kingdom, Guernsey, Jersey, South Africa and other countries and/or territories.

1.6 Your rights

You have the right to ask SFL not to process your data for marketing purposes. SFL will usually inform you (before collecting your data) if we intend to use your data for such purposes or if we intend to disclose your information to any third party for such purposes. You can exercise your right to prevent such processing by checking the opt-out boxes on the forms we used to collect your data or by contacting us at enquiries@stonehagefleminglaw.com at any time.



1.7 Access to information

The Law gives you the right to access information held about you and to have it corrected or deleted. Any access request may be subject to a reasonable fee to cover the cost of providing you with details of the information we hold about you.

1.8 Changes to our privacy policy

2 COOKIE POLICY

Our website (“site”) uses cookies to distinguish you from other users of our site. A cookie is a small file of letters and numbers that a website can store on the browser or hard drive of your computer if you agree. These cookies allow our site to identify you on subsequent visits to our site and for example, remember to log you in on that next visit.

By continuing to browse our site, you are agreeing to our use of cookies.

Cookies may be required to allow you to access and participate in certain areas of our site. The cookies we store on your computer do not contain any personally identifiable information.

3 ACCEPTABLE USE POLICY

 - 3.1.7.4 any equipment or network or software owned or used by any third party.

3.2 Suspension & Termination

SFL will determine, at our discretion, whether there has been a breach of this acceptable use policy through your use of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.

Failure to comply with this acceptable use policy constitutes a material breach of the terms of use upon which you are permitted to use this site, and may result in SFL taking all or any of the following actions:

- 3.2.1 immediate, temporary or permanent withdrawal of your right to use our site;
- 3.2.2 issue of a warning to you;
- 3.2.3 legal proceedings against you for reimbursement of all costs on an indemnity basis (including but not limited to, reasonable administrative and legal costs) resulting from the breach;
- 3.2.4 further legal action against you; and/or



3.2.5 disclosure of such information to law enforcement authorities as we reasonably feel is necessary.

SFL excludes liability for actions taken in response to breaches of this acceptable use policy. The responses described in this policy are not limited, and we may take other action we reasonably deem appropriate.
