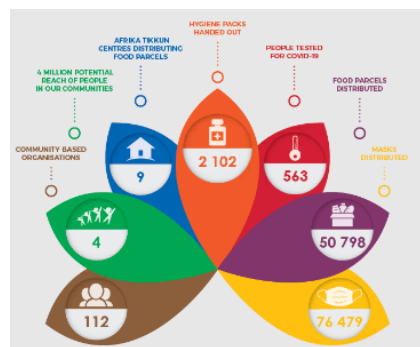

AFRIKA TIKKUN, SOUTH AFRICA

In response to the ongoing COVID-19 pandemic, the Group made a donation to [Afrika Tikkun](#). A number of clients also generously provided additional financial support to the cause.

Afrika Tikkun have been raising funds to provide food parcels and hand sanitiser for vulnerable families living in crowded, lower income settlements in South Africa. The charity's focus has been to mobilise a community-level response to the global pandemic in the Gauteng and Western Cape townships.



CENTREPOINT, LONDON

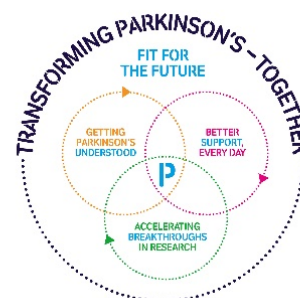
Donations have been made by the Group and our clients to help homeless, vulnerable young people across London and the UK.

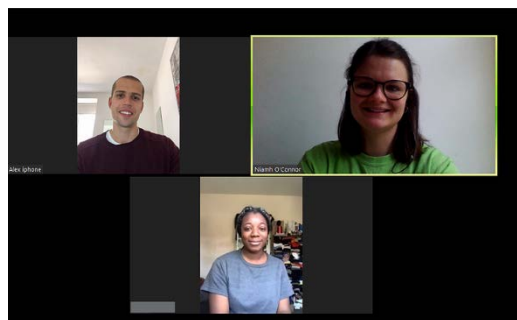
SFCF HIGHLIGHTS FOR H1 2020



Village Health Works – Support was provided through Stonehage Fleming Charitable Foundation to a Burundi based non-profit organisation which runs a 50-bed health centre in the rural south-west of the country.

Village Health Works has been making preparations in anticipation of the potential impact of COVID-19 in the region and the support will allow for additional operational resources.

Envision – Business mentors from the London office have been working with local students as part of an extended development programme.
