Since their renovation, the libraries have been home to reading clubs, national spelling competitions, mathematics and science Olympiads.

Launched in September 2015, the Wilbur and Niso Smith Foundation is a charitable organisation dedicated to empowering young writers, the advancement of the adventure writing genre and the promotion of literacy.

[North London Hospice](#) – Our Foundation supported the opening night of a week-long festival of music and culture to raise money for the North London Hospice. The event delivered a unique multi-faith evening in the surroundings of St Judes-on-the-Hill church in Hampstead Garden in London.
